Dear New Temple Beth Torah Member,

Welcome to Temple Beth Torah. Enclosed please find your Temple Beth Torah invoice for Dues, Building Fund (if applicable*) and Religious School Fees July 1, 2011 through June 30, 2012.

Temple Beth Torah offers a two tiered dues/tuition plan. If you choose the regular dues/tuition level you may pay by credit card (either in full, or automatically semi-annually, quarterly or monthly). We offer a discounted rate for those who choose to pay by check. We encourage you to use an automatic bank withdrawal plan if you choose to make monthly payments. **You will need to contact your bank to set up this plan.**

The attached invoice has the Dues and Tuition rate at the **discounted rate**. The regular rate with the option to pay by credit card is on the enclosed rate sheet. If you select the Regular Dues Rate Option we will send you a credit card authorization form and a new invoice.

 - Monthly payments whereby each payment is a percentage of your total obligation for the year, from the start of your membership through May 2012.**

You will receive a monthly invoice by email from Temple Beth Torah with the amount of payment due. Please contact the Temple if you change your email address or you do not receive the monthly invoice. Payments are due no later than the 15th of the month.
