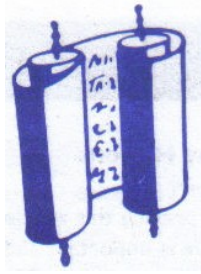

Enclosed please find your Temple Beth Torah invoice for Temple Dues, Building Fund (if applicable) and Religious School Fees for the year July 1, 2010 through June 30, 2011, plus any outstanding amount owed from the previous fiscal year.

We offer a number of payment options and financial aid for those who qualify. You must select an option for 2010 -2011 membership and tuition payments.

- **Temple dues and school tuition paid in full within 30 days of receipt of invoice**
- **Two payments (due September 1 and February 1) each for half of the annual obligation**
- **Quarterly payments (the total amount due divided into 4 equal payments due August 1, November 1, February 1, May 1)**
- **Monthly payments whereby each payment is 1/10<sup>th</sup> of your total obligation for the year. Payments begin August 2010 and completed in May 2011**

**Monthly payments by check are due no later than the 15<sup>th</sup> of the month.**

**The credit card authorization must be submitted each year.**

**Please indicate your payment choice with an 'x' and return this form to the Temple (with your signed credit card authorization if you choose that option). This form is due by July 31, 2010.**

**We ask you to consider using an automatic bank withdrawal for monthly payments. We do pay a processing fee for use of credit cards. Using a bank withdrawal means that all your dues/tuition payments come directly to the Temple.**
