**Discounted Rate** (Invoice enclosed)

The discounted rate allows you to pay by cash or check. This rate can also be used for automatic bank payment plans which you can set up with your bank so that your payment is automatically sent to the Temple.

**If you want the discounted rate as reflected on the enclosed invoice, select one box for billing:**

- Pay in full within 30 days**
- Semi-annual (total amount due divided into 2 equal payments; August & January)**
- Quarterly (total amount due divided into 4 equal payments; August, November, February & May)**
- Monthly (total amount due divided into 10 equal payments from August through May)**

**Regular Rate** (Fee Schedule enclosed)

The regular rate allows you to pay by credit card in full, semi-annually, quarterly or monthly. Temple Beth Torah has a number of policies that we would like to highlight:

- You must be a member in good standing (all previous years' financial obligations met) in order to receive High Holiday Seats and to enroll your child in religious school.
- If you have a B'nai Mitzvah during this year, the policy requires that all outstanding bills (including Religious School for all members of your family) be paid in full at least one month prior to the event or be fully guaranteed with automatic bank withdrawal payments.
- All Temple Members who have a child or grandchild enrolled under their membership in the Religious School from Kitah Aleph through Confirmation must be a member in one of the following membership categories: Family, Interfaith, or Single Parent (as applicable). The Senior Rate will not apply.

Temple Beth Torah is dedicated to providing a place of worship and education to all Jewish members in our community. If you think you are unable to meet the financial requirements, please contact Adam Miller, Finance Committee Chair at [amiller-tbt@comcast.net](mailto:amiller-tbt@comcast.net) to discuss the matter confidentially.
